RACE 1 – www.hrgc.com.au Juvenile 461 Metres

Casso Mac Matt was very slow out. Tour De Lance was slow out. Apache Magic, Danny Ocean and Jazollie collided soon after the start. Fine Magic, Strong Magic and Tour De Lance collided approaching the first turn. Jazollie checked off the heels of Apache Magic on the first turn checking Myalla Tyrant and Casso Mac Matt. Danny Ocean checked off the heels of Fine Magic approaching the home turn.

RACE 2 – Minister’s Gift Special Event Heat 6 Heat 461 Metres

He’s Capable and Arctic Silver were slow out. Shale Boy and Smart Asco collided soon after the start. Bill’s Bird, Buckle Up Coke and Edan’s Champ collided soon after the start. Shale Boy galloped on the heels of Arctic Silver approaching the home turn. Buckle Up Coke was examined by the club’s Veterinary Surgeon and it was reported that no apparent injury could be detected.

RACE 3– Glenorchy City Council Mixed 4/5 599 Metres

Arnhem Illusion and Paragon Star were slow out. Amargosa and Arnhem Illusion collided soon after the start. Instant Rockstar and Astral Moon collided on the first turn. Arnhem Illusion, Paragon Star, Amargosa and Dyna Maid collided entering the back straight and again approaching the second turn. Astral Moon checked off the heels of Koocanusa approaching the home turn. Arnhem Illusion and Paragon Star collided on the home turn. Stewards directed that a post race urine sample be taken from Instant Rockstar, winner of the event, as this run time of 34.53 is a new track record over the 599m distance. Astral Moon was examined by the club’s Veterinary Surgeon and it was reported that the greyhound was suffering from the condition thumps however no penalty was applied. Koocanusa was examined by the club’s Veterinary Surgeon and it was reported that the greyhound had a lacerated toe which required suturing and has been stood down from competing for 7 days.

RACE 4 – Minister’s Gift Special Event Heat 7 Heat 461 Metres

Camdale Wolfe was slow out. Brother Jack, Posh Bluin’ and 4 collided soon after the start checking Posh Bluin’, Kialdu Ruby and Camdale Wolfe. Kialdu Ruby checked off the heels of Taite’s Star on the first turn and collided with Camdale Wolfe. Brother Jack faltered approaching the home turn colliding with Taite’s Star. Brother Jack subsequently tailed off. Taite’s Star raced wide on the home turn. Brother Jack was examined by the club’s Veterinary Surgeon and it was reported the greyhound was injured with a fractured right hock. Acting under the trainer’s authority the greyhound was euthanased by the club’s Veterinary Surgeon.

RACE 5 – Minister’s Gift Special Event Heat 8 Heat 461 Metres

Where’s Ned, Camdale Callie and Blofeld were slow out. Son Of Edan, Cope and Crime Fighter collided approaching the first turn checking Cope and Camdale Callie. Cope and Camdale Callie collided on the first turn. Crime Fighter galloped on the heels of Son Of Edan approaching the home turn. Blofeld eased approaching the home turn. Blofeld was examined by the club’s Veterinary Surgeon and it was reported that the greyhound was injured in the left hind and has been stood down from competing for 5 days. Stewards charged Blofeld pursuant to GAR 69(5) in that the greyhound failed to pursue the lure with due commitment but did so by reason of injury. Stewards directed that Blofeld complete a satisfactory trial all tracks before any further nomination be excepted. Son Of Edan was examined by the club’s Veterinary Surgeon and it was reported that the greyhound had minor lacerations to the left hind however no penalty was applied.

RACE 6 – Sky Racing Mixed 1/2 461 Metres

Little Spaniard and Pedro Pronto were slow out. Stylish Monty and Rocket Moss collided soon after the start. Pedro Pronto and Stylish Monty collided soon after the start checking Stylish Monty, Rocket Moss, Topline Doovee and Monasito. Stylish Monty and Monasito raced wide and collided on the home turn. Rocket Moss and Topline Doovee collided entering the home straight. Topline Doovee was examined by the club’s Veterinary Surgeon and it was reported the greyhound was injured in the right hind and has been stood down from competing for 5 days.

RACE 7 – Minister’s Gift Heat 9 Special Event Heat 461 Metres

Big Zues, New Wonder, Troublesome Miss and Bandit’s Mistake were slow out. New Wonder checked off the heels of Em’s Solo soon after the start checking Em’s Solo. New Wonder and Troublesome Miss collided approaching the first turn. Rulla Shaw, Hellyeah Reg and Bandit’s Mistake collided approaching the home turn checking Bandit’s Mistake. Bandit’s Mistake galloped on the heels of New Wonder on the home turn. Bandit’s Mistake was examined by the club’s Veterinary Surgeon and it was reported that the greyhound was injured in the left hind and has been stood down from competing for 5 days.

RACE 8 – The Mercury Grade 4 461 Metres

Sheer Octane, Rate A Win and Chalk Hill collided soon after the start. Hellyeah Maggie, Parsipanny, Toucha Bandit and Hellyeah Bess collided soon after the start checking Hellyeah Bess. Hellyeah Bess faltered approaching the first turn and lost ground. Chalk Hill and Hellyeah Bess collided on the home turn. Hellyeah Maggie and Toucha Bandit collided on the home turn, home straight and again approaching the winning post. Stewards directed that a post race urine sample be taken from Ricky Satin, winner of the event. Toucha Bandit was examined by the club’s Veterinary Surgeon and it was reported that the greyhound was injured left hind and will be stood down from competing for 7 days. Stewards issued a warning on Toucha Bandit’s racing manner in the home straight. Hellyeah Bess was examined by the club’s Veterinary Surgeon and it was reported that the greyhound was injured right hind and was stood down from competing for 7 days. Stewards issued a warning on Hellyeah Bess’ racing manner soon after the start and approaching the first turn.

RACE 9 – Minister’s Gift Heat 10 Special Event Heat 461 Metres

Buckle Up Man was slow out. Sting checked off the heels of Callamac Lad soon after the start. Stylish Bernie and Buckle Up Man collided approaching the first turn. Abira, Sting and Chudley collided approaching the first turn. Stylish Bernie checked off the heels of Chudley on the first turn checking Chudley. Chudley checked off the heels of Stylish Bernie approaching the home turn. Chudley was examined by the club’s Veterinary Surgeon and it was reported that the greyhound was injured in the left hind and stood down from competing for 10 days.

RACE 10 – The Mercury Grade 5 461 Metres

Amelia’s Pride was slow out. Light A Bomb, Archer’s Eleven, Kialdu Zircon and Go Maggie Go collided soon after the start. Light A Bomb checked off the heels of Kialdu Zircon on the first turn. Go Maggie Go and Joe’s Lexi collided on the first turn. Archer’s Eleven checked off the heels of Joe’s Lexi approaching the home turn. Light A Bomb was examined by the club’s Veterinary Surgeon and it was reported that no apparent injury could be detected.

General:

Starlight Ebony completed a steward's satisfactory trial pursuant to LR (TAS) 31(3) as the greyhound has not competed in an event for more than 6 months. Weighing 29.6kg and beginning from box 3, Starlight Ebony completed the 461 Metre distance in the time 27.64. This greyhound has not been cleared to race as it failed to run the qualifying time.

Hold On Ute completed a stewards satisfactory trial after the greyhound was stood down at LHRC 10.08.09 pursuant to GAR 69(5) for failing to pursue the injury with due commitment but did so by reason of injury. Weighing 33.4 and beginning from box 5, Hold On Ute completed the 461 Metre distance in the time of 27.47. Stewards noted that Hold On Ute eased on the first turn and failed to complete the course to the satisfaction of the stewards. Hold On Ute has not been cleared to race.
