RACE 1 – betfair.com Juvenile Graduation 515M

Western Queen was very slow out and faltered soon after the start losing considerable ground. Silver Rock was slow out. Parsipanny and Hudson collided soon after the start. Hudson and That's His Go collided entering the back straight. Edan's Champ and Cracker Boy collided on the third turn. That's His Go and Silver Rock collided on the third turn. That's His Go contacted the running rail approaching the home turn checking That's His Go which collided with Silver Rock. That's His Go and Silver Rock collided entering the home straight. Western Queen and That's His Go collided in the home straight. Lake Tahoe and Edan's Champ collided approaching the winning post. That's His Go was examined by the club's Veterinary Surgeon and it was reported that no apparent injury could be detected. Edan's Champ was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the left and right tensor muscles and has been stood down from racing for a period of 8 days. Stewards queried Edan's Champ race manner on the third turn, a warning was issued on this occasion. Western Queen was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the lumbar and has been stood down from racing for a period of 10 days. Pursuant to GAR 71 Stewards deemed the performance unsatisfactory and directed that the greyhound perform a satisfactory trial all tracks.

RACE 2 – Schweppes Grade 4 278M

Stewards directed that a post race urine sample be taken from Luv Ya Johnny, winner of the event.

Dry Shiraz and First Alarm collided on the home turn checking Dry Shiraz, Booma Bink and Jet Light. Denhill Star was examined by the club's Veterinary Surgeon and it was reported that no apparent injury could be detected.

Big Storm was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the left tensor facia muscle and has been stood down from racing for a period of 10 days.

Hellyeah Bess was examined by the club's Veterinary Surgeon and it was reported that no apparent injury could be detected. Pursuant to GAR 69(1)(b) Stewards charged Hellyeah Bess with failing to pursue the lure with due commitment and pursuant to GAR 69(2)(a) Hellyeah Bess has been stood down from racing for 28 days at the Launceston Greyhound Racing Club and until the completion of a satisfactory trial all tracks.
