Courier School checked off the heels of Edan's Rocket entering the front straight on the first occasion checking Collins Cap. Krytarah Blue, Courier School and Collins Cap collided on the second turn. Courier School and Collins Cap collided on the third turn. Krytarah Blue and Edan's Rocket collided on the fourth turn. Manizzy Shiraz was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the left triceps and has been stood down from racing for a period of 5 days. Pursuant to GAR 69(5) Stewards charged Manizzy Shiraz with failing to pursue to lure with due commitment, but did so by reason of injury. Stewards directed that a satisfactory trial be performed all tracks before any further nominations will be accepted.

Chinatown Lad was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the left wrist and has been stood down from racing for a period of 21 days. In Harms Way was examined by the club's Veterinary Surgeon and it was reported that no apparent injury could be detected. Stewards directed that a post race urine sample be taken from Agent Rusty, winner of the event and Amargosa, placed second in the event. The timer malfunctioned in this event and the times were subsequently hand timed.

RACE 4 – Schweppes State National Distance Championship – Heat 2 720M

Ultra State faltered at box rise and subsequently pulled up. Hold On Ute faltered approaching the winning post and pulled up. Ultra State and Hold On Ute did not finish the event. Ultra State was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the right tensor facia, upper quadriceps (painful on hip extension) and has been stood down from racing for a period of 10 days. Pursuant to GAR 71 Stewards deemed the performance unsatisfactory and directed that Ultra State perform a satisfactory trial all tracks before any further nominations will be accepted. Hold On Ute was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the right triceps and has been stood down from racing for a period of 10 days. Pursuant to GAR 69(5) Stewards charged Hold On Ute with failing to pursue to lure with due commitment, but did so by reason of injury. Stewards directed that a satisfactory trial be performed all tracks before any further nominations will be accepted. Stewards directed that a post race urine sample be taken from Instant Rockstar, winner of the event and Regent Satin, placed second in the event. The timer malfunctioned in this event and the times were subsequently hand timed.

Uno Sparky checked off the heels of Belanski on the home turn checking Em's Solo. Uno Sparky was examined by the club's Veterinary Surgeon and it was reported that the greyhound had superficial grazes, however no stand down penalty was applied. Lady Nova was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the right hind and has been stood down from racing for a period of 10 days. Stewards directed that post race urine samples be taken from Fallen Zorro, winner of the event and from Belanski, placed third in the event. The timer malfunctioned in this event and the times were subsequently hand timed.
