RACE 1 – Western Bulldogs Football Club Juvenile 461 Metres

Hot Speed was slow out. Decembrist and Top Choice collided on the first turn severely checking Decembrist. Hot Speed, Domaine and Tour De Lance collided on the home turn. Decembrist was examined by the Club's Veterinary Surgeon and it was reported to be injured in the right shoulder and has been stood down from competing for 7 days.

Broadwater Boy was slow out. Calins Star and Allnighter collided soon after the start. Calins Star and Marbo Lafourche collided soon after the start checking both greyhounds. Broadwater Boy checked off the heels of Calins Star on the home turn. Marbo Lafourche raced wide in the home straight. Kiana Wabbit and Little Bee Dee collided approaching the winning post. Calins Star was examined by the Club's Veterinary Surgeon and it was reported to have painful left wrist, painful quadriceps left hind leg and has been stood down from competing for 10 days.

RACE 7 – Daniel Giansiracusa Invitation 461 Metres

Pedro Pronto was examined by the Club's Veterinary Surgeon and it was reported to have muscle soreness right hind leg and has been stood down from competing for 7 days.

Disdain was examined by the Club's Veterinary Surgeon and it was reported to have muscle soreness left hind leg and has been stood down from competing for 5 days.

General:

Capetown Terror completed a stewards satisfactory trial pursuant to GAR69 (5) after the greyhound was stood down at HGRC 04.07.09 for failing to pursue the lure with due commitment due to injury. Weighing 29.1kg and beginning from box 5. Capetown Terror completed the 461 metre distance in the time of 26.68 and has been cleared to race all tracks.

Archers Eleven completed a stewards satisfactory trial pursuant to GAR69 (5) after the greyhound was stood down at NWGRC 22.09.09 for failing to pursue the lure with due commitment due to injury. Weighing 34.8kg and beginning from box 3. Archer Eleven completed the 461 metre distance in the time of 26.74 and has been cleared to race all tracks except Devonport.

Babis completed a stewards satisfactory trial pursuant to GAR69 (1)(a) after the greyhound was stood down at Ballarat 02.09.09 for marring the running of another greyhound in an event. Weighing 29.1kg and beginning from box 5. Babis Terror completed the 461 metre distance in the time of 27.07. Stewards noted the Babis marring another greyhound in the home straight and therefore has not been cleared to race.
