Stewards spoke to trainer B J Adams in regard to Da Fencer's racing actions in the home straight. Stewards charged Da Fencer pursuant to GAR 69(2)(b) for marring the running of another greyhound in an event and the greyhound has been stood down from racing for a period of three months and until the completion of a satisfactory trial all tracks. Silky Black was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the left and right quadriceps and has been stood down from racing for a period of 3 days. Ricky's Boy was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured in the right hind quadriceps and has been stood down from racing for a period of 3 days.

Thirteen Black was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured with tenderness in the right quadriceps and has been stood down from racing for a period of 2 days. Son Of Edan was examined by the club's Veterinary Surgeon and it was reported that no apparent injury could be detected.

Licence To Live was examined by the club's Veterinary Surgeon and it was reported that the greyhound was injured and has been stood down from racing for a period of 12 days. Stewards spoke to trainer D J Crosswell in regard to Licence To Live's performance in this event. Stewards charged Licence To Live pursuant to GAR 69(5) for failing to pursue the lure with due commitment by reason of injury and the greyhound has been stood down from racing until the completion of a satisfactory trial all tracks. Trainer M B Stringer was fined \$25 pursuant to GAR 48 for having no catcher for Empires, in this event.
