No regard eased approaching the first turn and collided with Kialdu Eddy and Greysynd Mirage. No Regard checked off the heels of Kialdu Eddy on the first turn. Kialdu Eddy was examined by the club's Veterinary Surgeon and it was reported the greyhound was injured in the left shoulder and will be stood down from competing for 5 days. No Regard was examined by the club's Veterinary Surgeon and it was reported the greyhound was injured in the left wrists and will be stood down from competing for 10 days. Pursuant to GAR 69(5) Steward's charged No Regard for failing to pursue the lure with due commitment but did so by reason of injury and directed that greyhound perform a satisfactory trial all tracks before any further nomination be accepted.
