Pursuant to GAR 69(1)(b) Stewards charged Merls Bomber with failing to pursue the lure with due commitment in the event. Pursuant to GAR 69(2)(a) Stewards will stand Merls Bomber down from racing at the Launceston Greyhound Racing Club for a period of 28 days and until the completion of a satisfactory trial all tracks.
